PREFACE

The indexes to the Legal Papers and Family Papers of Tomlinson Fort were compiled in part from cards and lists done by the WPA with changes and/or additions provided by CHCBL staff during reprocessing of the collection in 1980. Both indexes are arranged in chronological order like the papers.

In the Legal Papers index is found the notation,"empty legal envelope." This is due to the fact that some of the envelopes containing documents were marked empty by the WPA and those documents were not found during reprocessing. "owever, the legal envelopes were kept and the data from them entered in the index.

Another notation found is "original," which denotes the item was Tomlinson Fort's document. Some of these are handwritten and some are typed legal copies. The use of "typescript" denotes a WPA typed transcript or abstract of a document. Several abbreviations used in the description of a document are as follows:

reg. = registered
rec. = recorded
ack. = acknowledgement
cert. = certificate or certification

To facilitate ease in recording data, the names of family members in the Family Papers index have been standardized and a notation of this has been made in the "description column" of the index.
